## General information

- Forscope provides this documentation for **Microsoft perpetual software products**. Licenses from other software manufacturers come with different types of documentation.
- There is no official template for the visual look of the documentation, that's why it might differ in terms of graphic design. However, the factual content is always the same and confirms the fulfilment of legally required conditions for the transfer of software ownership.

## Sample documentation legend

Numbers in black circles showed throughout this document correspond to the respective EU law requirement, which you can find stated below:

- 1 The first country of usage was within EU/EEA, or Switzerland.
- 2 The product was paid in full to the copyright owner.
- 3 The product is perpetual with no time limit for use.
- 4 The product is no longer in use by the first owner.

5. All Products are **perpetual**, with no time limit for use.
6. All Products can be used by companies and organizations from both the **private and public sectors**.
7. Products are no longer in use by any user; **previous owner(s) have uninstalled or made the Products unusable for themselves**.
